INTRODUCTION

Compilation of the Sutherd family data in Virginia and Illinois was very difficult due to the fact that in many documents the name was found mixed with Suddoth, Southard, and/or Suthard. Some documents would have the spelling in two or more ways. All records with Suddoth have been discarded and only those of Suthard, Sutherd, or Southard have been used in this compilation. Documents which have been researched contained sufficient evidence to establish the lines herein developed. There remains considerable research available to the ambitious ancest-orto broaden the details already uncovered.

The following data starts with Robert Suthard, wife Diana, of Stafford County, Virginia. His known issue was 2.1 John Suthard, 2.2 Absolom Suthard, 2.3 Moses Suthard. Hence, the first digit such as 1,2,3,4,5,6,7,8,9 denotes the generation from Robert Suthard of Stafford County, Virginia who is generation 1. The second digit after the decimal point denotes the children of the generation found in the first digit. Please note that numerical order of an issue does not denote necessarily the order of birth of the subject issue. No attempt has been made to extend the generations beyond the 8th, sometimes the 9th, but not beyond the 9th. Several lines do not extend beyond the early generations due to absence of sufficient data.

Some say the Southards are all descended from the ancient Southworth family of Somersetshire and Lancashire, England, which derived its name from the Southworth estate in the barony of Newton. The name Southard seems to have been a Dutch variation of the English name Southworth as the Southworths were among many English families who fled England in the 1500's to escape religious persecution. They settled in and near Leyden, Holland. In Holland they raised their families, intermarried with the Dutch, and adopted the Dutch language. Later some of their decendants came to America. Some settled in New England, while others settled in Long Island, N.Y. and Virginia. In America the name is found spelled Southard, Southerd, Suthard and Sutherd. There was a great similiarity in all areas of colonial America of the spelling of the given names of the males, such as, John, Joseph, Isaac, Elias, Moses, Robert, Benjamin, Thomas, Levy, Francis, George, Calvin, and William.

There was a Thomas Southard who first appeared in the Virginia-Maryland records in 1666 which was a few years after another Thomas Southard from Leyden, Holland appeared in Long Island, N.Y. in 1640 and died in 1688-90 lt is not known if the Thomas Southard of Maryland in 1666 was the progentor of the Virginia Southards of the 18th century.

From the death records on file in Page County, Virginia, we learn that Lewis Southard's father was Moses Southard of Stafford County, Virginia. The record does not state his mother's name. In the St. Paul's Parish Register of Stafford and King George counties (by Nicklin) and the deed records of Stafford County, Virginia are found the following: -

There may have been other issue but no documentary evidence to date has been found to so state. From the Overwharton Parish Register of Stafford County, Virginia there was a Rose Suthard who married Silent Jefferys Jan. 19,1744. She could have been a dt. of Robert & Diana Suthard. And then from Will Book I, p. 384 Fauquier County, Virginia is the will of Francis Suthard, dated Oct. 2,1779, proved Nov. 22,1779. In it he named wife Elizabeth and children Elizabeth, Sarah, Germina, Levi, William and George. He also might have been a son of Robert and Diana Suthard.



From the records the Moses Suthard, b.9/22/1732 (St.Paul's Parish Register) and the Moses Southard in the 1830 U.S.Census of Madison County, Virginia, age 70/80, had to be two different Moses Southards. The death certificate of Lewis Southard, b.1788, stated that his father was Moses Southard of Stafford County, Va. If they were the same the age of the Moses Southard in the 1830 census / would have been 98, but he was in the 70/80 bracket. From all the documentary facts it appears that the Moses Southard of the 1830 census in Madison County was a son of the Moses Suthard of Stafford County, Virginia. Furthermore the issue of Moses Suthard of Stafford County although never so documented, but yet strong circumstantial evidene exists that the following were some of his issue.

MOSES SOUTHARD of MADISON COUNTY, VA.

3.1 Moses Southard, b. cal755, d. before Oct.25, 1838, Md. not known. His will proved Oct.25, 1838 (Will Book 6, page 397, Madison Co., Va.) was proved by John Lewis. No wife is named in his will as she was perhaps deceased. Their last child to be born was in 1806 and his wife does not show in the 1810 census. Children named in his will were Susan, Betsy, Lucy, Sarah, Jenny, Elias and Isaac. Lewis was left out of the will prehaps due to some family controversy over a debt.

The following legal document appears in Deed Book 8. page 40

1823-1833, Madison County, Virginia.

"This endenture made and entered into this 7th January 1824 between LEWIS SOUTHARD of Madison County, State of Virginia of the one part and Elias Southard of the same county of the other part. witness that the said LEWIS SOUTHARD in order to secure the payment of \$40 due from said LEWIS SOUTHARD to Moses Southard by bond and open account and in consideration of one dollar to himin hand paid by said Elias Southard at or before the ensealing and delivery of these presents, the receipt thereof is hereby acknowledged, by the said LEWIS SOUTHARD hath bargained and sold and by these presents doth bargain and sell unto said Elias Southardthe following property-viz: gray horse, 1 cow and calf, 10 hogs, 1 feather and two straw beds, 2 double counter panes, 2 single counter panes, 2 linen sheets,3 bed sheets,1 loom,2 slays,2 pair harness,1 bed quilt,2 flag bottom chairs, i old desk, I walnut and pine table, 3 motby hogsheads, 1 was tub, 2 pigeons, 1 axe, 2 billing hoes, 1 grubbing hoe, 1 plow, plates, dishes, knives, forks, cups, saucers, 5 milk pots, cotton wheel, flax wheel, looking glass, together with all and singular or in any way appertaining to the above named property to have and to hold the property hereby conveyed unto him the said Elias Southard and his heirs in trust for the purpose foresaid provided nevertheless that if said LEWIS SOUTHARD shall will and truly pay unto said Moses Southard the aforesaid sum of money withinterest that may accrue thereon until the day of payment whenever he shall be here with required so to do by said Moses Southard and shall also pay the expenses attending this deed of trust then and such case this deed of trust and every clause herein contained shall be void and of none effect. But on the other hand the said LEWIS SOUTHARD shall fail to pay the aforesaid sum of money with interest as aforesaid when he shall be there unto requested so to do so by the said Elias Southard and also pay the expenses attending this deed of trust then and in in such case the said Elias Southard being requested to do so by the said Moses Southard may proceed to sell the property afore-said having first advertised the time and place of sale for ready money for the best price that can be obtained and out of these proceeds thereof in the first place pay all charges attending the execution of this deed of trust and then pay the said Moses Southard the afore said sum of money with interest thereon as aforesaid and the balance, if any, pay the said LEWIS SOUTHARD.

In testimony whereof the said LEWIS SOUTHARD and Elias Southard

have hereunto set their hands and affixed their seal, this day and

year first written.

X Southard seal Lewis Elias Southard seal Madison County Clerk's Office January 12th, 1824. This deed from Lewis Southard to Elias Southard in trust for Moses Southard was acknowledged by said Lewis Southard and Elias Southard and admitted to the records. And at a Court held for said county the 22nd day of January 1824, the said deed was certified to court and inserted in the minutes." Tests

Thus from this indenture it is evident that Lewis Southard owed his father Moses Southard \$40 and that he wanted the money so he took his son to court to get a judgement. Indentures for a debt almost always indicates hostility between the debtor and debtee. They can also indicate friendship between the debtor and cosigner, in this case Elias Southard, a brother of Lewis Southard. Furthermore, for Moses to insist via of the court that his son Lewis pay him the \$40 even if he had to sell his animals, farm implements, household goods and furnishings even down to the knives and forks, clearly indicated that they were at odds. That Elias came to his brother's rescue suggests that he was on Lewis' side. Otherwise, Lewis could have been jailed to obey the court order Moses Southard obtained. Hence, there is reason to understand why Lewis Southard was left out of his father's will.

WILL OF MOSES SOUTHARD, MADISON COUNTY, VIRGINIA Proved Oct. 25, 1838, Will Book 6, page 397, Madison County, Virginia.

"I, Moses Southard of the county of Madison and state of Virginia make this my last will .I want my Executor to have all financial expenses and my just debts paid.I then bequeathed my daughter Jenny Southard my two bedsteads and furniture, also my cotton wheel and her choice of one of my cows. My next will that the balance of my property be sold at twelve months credit and the proceeds be equally divided between the children to wit:— Susan Preston, Betsy Lloyd, Lucy Taylor, Sara Smith, Jenny Southard, Elias Southard, Isaac Southard, to them and to their heirs. My last will is that William W. Lewis act as my Executor."

Hence Lewis Southard was born Nov.1788 in Stafford Co., Virginia, died in Page Co., Va. August 16,1870. Not known where buried. He married Dec. 21,1816 Madison Co., Va. (Madison Co. Marriage Records) Mary McAlester, dt. of James and Eve McAlester of Madison Co., Va. James McAlester was in the Revolutionary War drafted from Culpeper Co., Va. (Draft Records, Culpeper Co., Va.).

Lewis Southard appeared in the 1810 Census of Madison Co., Va. with Moses Southard in the 16/26 age group. He was Md. in 1816 and appears in the 1820 Census of Madison Co., Va. m.26/45-1,0/10-2; f.26/45-1,0/10-1. He moved to Page Co., Va. in the late 1820's.



When Lewis died in Page County, Va.he did not leave a will. however, a document of some size was recorded on August 6,1871 in Page Co., Va., naming his heirs and how his real estate was divided among them. The heirs names were Polly (Mary), his wife; children named were Thomas, Catherine, wife of William H. Petit, Sallie, wife of Reuben Verner, Annie, wife of Gideon Hook, John and the heirs of his deceased son William Henry Southard who were also named, John H. Southard, Elizabeth Jenkins, Joshua C. Southard and Clarinda Smith.

In correspondence, which extended back to June 1955, with Mrs.Salena Titlow of Page County, Va., a descendant of Thomas Moses Southard, son of Lewis Southard, and nearing 90 years of age, she told much of the structure of the family of Lewis Southard. She stated that he came to Page County from Madison County, She stated that one of the sons of Lewis Southard named William Henry Southard, and his wife were either killed or died when their children were very young. She stated that Lewis and Mary Southard, the children's grandparents, took them to raise. This statement was proved, first, by the settlement of the estate of Lewis Southard, as a part was left to the heirs of Henry Southard and naming them. Secondly, in the U.S.Census 1850 (see above) Page Co., Va. all but Elizabeth are listed in the household of Lewis Southard. The fact that Elizabeth did not appear in the household of her grandparents suggests that she was an infant and perhaps still living with

her mother who was yet alive. Elizabeth appeared in the settlement of her grandfather's estate as Elizabeth Jenkins. Thus in 1871 she had been married to a Mr.Jenkins. At the time of her death Mrs. Titlow was living on the home place of her father, Thomas Moses Southard; a place about four miles east of Stanley, Virginia, Page County, a place called Pine Grove. Her daughter Mrs. Clara Dean lived with her and continued to live there after her mother's death. Most of the document on the settlement of the estate of Lewis Southard was the description of the parcels of land awarded to each heir.

Trenton, Jerry and a dt. Sally does not aplear. Jerry and Trenton were working on a Mr. Beard's farm and

they are so recorded in the household of Mr. Beard. The daughter Sally only appears in the Bible record and it is not known if she came west with the family, or died before they left for Illinois. After the death of her husband Sarah Ellen (Breeden) Sutherd married in Virginia, Ill., Sept. 23, 1885 John T. Peek of Chandlerville, Ill., father Jeremiah Breeden, mother Mildred Nichols. Witnesses, Viola Decker, (a neice), Mildred Nichols (her mother) and Tom Meade (a merchant).Lic. #4349,Cass Count Court House, Virginia, Ill. He was a Civil War veteran of the Union Army and after living a few years in Chandlerville, he died. Sarah Ellen with her sons, Jerry, William and George moved back to a farm not far from where they originally settled but in Twp. 17 on the Subrink farm. William died in 1899 and Jerry died in 1913. She and her son George left the farmsite and lived in Virginia Illinois where she died in 1918.

Stonewall Jackson with some other officers came riding up just as in the distance a Union dispatch rider was going down the road on horseback. The general jumped off his horse laid one of the artillery pieces and order it to be fired. They saw the Union rider and horse fall but they all figured a sniper had shot them.But, "Uncle Jack" added that later that day they advance and went along on the road where the Union rider had fallen. "And do you know to the surprise of everone, that the cannon ball from Gen. Jackson's cannon hit that horse right back of the rider and killed them both". That ended my stories about W.W.I. I was in Bat.D., 128th Field Artillery, 35 Div. 7.1 Edward Smith. (Only known issue).

Will of Finley J.McAlester, dated Sept. 28, 1766, probated January 21,1771, Culpeper County, Va., recorded Will Book "B", page 13.

"In the name of God, Amen.

Item I give and bequeath to my two sons James McAlester and Robert McAlester the remaining two hundred forty acres of land of the above tract of three hundred sixty acres to be equally divided between them and their heirs forever. And my will and desire is that if any of the above named sons John, James and Robert McAlester die without heirs of their body lawfully begottenthen in that case I give and bequeath the whole tract to the survivor or survivors and to their heirs forever. Item I give and bequeath to my three daughters Elizabeth Hanson, Catherine Hanson and Mary McAlester the tract of land whereon Charles Hanson now lives containing two hundred fifty acres to be equally divided between them and to their heirs forever provided and it is my will and desire that my daughter Elizabeth have her part laid off at the place and whereon she now dwells on and my daughter Catherine Henson to land have the part next to the place she now lives on as also Mary McAlester to have her part laid off between the place whereon I now live. Charles Henson..... to the outer bounds of the said tract and if my daughter Mary McAlester should die without heirs of her body lawfully begotten I bequeath her part to my daughter Ann McAlester. Item, I give and bequeath to my daughters Sarah McAlester and Ann McAlester one tract of land containing one hundred twenty acres joining Major Roolou and John Froggs lines to be equally divided between them to them and their heirs forever......Item, I give and bequeath to my son William McAlester the Plantation whereon I now live and one hundred sisty acres of land there unto belonging after my wife deceases to him and his heirs forever. But if said son William McAlester should die with - out heir of the body lawfully begotten I leave and bequeath the said land and Plantation to be equally divided between my daughters aforesaid after the decease of my Loving wife Elizabeth McAlester. Item, I give and bequeath to my dearly beloved wife Elizabeth McAlester and to herand at her disposal all the rest of my estate goods and chattels Household Goods, cattle, hogs, and horses and every other thing belonging to me as Personal Estate and also leave her in full and free possession of the houses and Plantation whereon I now live and is to continue during her natural Life in possession of the land thereunto belonging containing one hundred and sixty acres for and during her natural life, and to continue thereon without any interruption, hinderance or molestation of any person or persons whatsoever during her natural life and lastly do hereby appoint my dearly beloved wife Elizabeth McAlester whole and sole executrix of my last will and testament. In Witness whereof I have hereunto set my hand and affixed my seal this twenty eight day of September in the Year of our God One Thousand Seven Hundred Sixty Six.

The chair of the commission stated "Each part of the land and personal estate is \$32.81 which I have paid all the children but Joab McAllister who lives in Kentucky but where I cannot find out which part I am ready to pay at any time. July 26,1821."

Recorded July 28,1821, Madison County, A suit to set aside the above commissioner's report. File #8.

This suit was filed by Elijah Powell and his wife Sally (Mc-Alister), dt. of James McAlister. In the commissioner's action the widow Eve McAlister, mother of the twelve children mentioned in the papers was not given her dower rights. The court agreed to her dower rights and for her to hold during her natural life, thus setting aside the above decree.

Comment: - My earliest recollection of grandmother Sutherd was in 1899 at the funeral of her son William "Billy" as he was fondly called. I was deeply moved at the early age of four the meaning of death and what the loss means to those living. At the grave site on the Sutherd lot in Walnut Ridge Cemetery I can still hear those heart breaking sobs and mourning of grandmother Sutherd. During the following years I became deeply attached to her and I spent many visits of many days on the farm west of Ashland, Ill. After Uncle Bill's death Uncle Jerry and Uncle George continued to live with her on the farm. She was as fine and noble woman

who ever lived. Slender and erect body, dark complexioned, black hair and the most kindly, loving, big dark eyes. She never had a cross word for what ever happened and was constantly working at something, such as, in the garden, preparing the next meal, baking, washing, mending clothes, washing and all the numerous duties required on a farm in those days of toil. Her husband John Henry Sutherd was light complexioned, blue eyes, and light brown hair. It was interesting to note from a genetic point of view that their sons, Joseph, Trenton, Jerry, and Charley were all dark complexioned and brown eyes like their mother, while sons Thomas, William, and Albert were blue eyed and light complexioned like their father. Son George had blue eyes and was dark complexioned, and he was the youngest.

Many a hot summer day she would sit in an old chair in the front yard in the shade of large maple tree. Her apron would be full of freshly gathered string beans from the large garden near by. She would often tell me of her home back in the Shenandoah Valley in Virginia and about the time the Union Army raided their farm taking all live stock, cutting down the fruit trees, burning the haystacks and taking any hams visible to take. They managed to live on the potatoes, ham and other estables they managed to hide away from the raiders. After the war ended she said it was a desolate and ravaged country, they were very poor and only thru the sale of some inherited land were they able to move out to Illinois. She also told me that the Breeden line had Indian blood in them thought to be Cherokee.

After her son Jerry died in 1913, they gave up the farm and Uncle George and Grandmother moved to a small tract of land on the outskirts of Virginia, Ill.

They lived at the south east edge of Virginia, Illinois at a part then called "Grand Villa". Their place was a perfect example of the transition period of rural colonial life to

urban living. They made their clothing using an early model of a sewing machine whose operation fascinated me. They made their soap from fats and the lye obtained from the run off rain water going thru a barrel of wood ashes. They butchered their hogs after the first frost in the fall making hams, sausage, lard, bacon and head cheese. From their cows they made butter, cheese and home made ice cream so delicious that one could eat a gallon. Numerous and various fruit trees grew on their place as well as blackberries, raspberries and currants. Each season all the fruit and berries ended up into jars of jams, jellies and perserves. The apples were made into apple butter and many were stored in the cyclone cellar for future use during the cold winter months.

They grew about everything in their large garden, turnips, potatoes, parsnips, oyster plant, beans, peas, lettuce, egg plant, carrots, tomatoes, rubarb, celery, strawberries and cucumbers. I was always struck by the way they would squirrel away the apples and vegetables for winter use. They would dig a large rectangular pit a foot or so deep and cover it with straw on top of which they placed the vegetables. More straw would be placed on top of the vegetables which would be covered with a heavy sheet of canvas. The entire area would be covered with a deep ; ayer of the black earth and all was ready for winter. During the winter vegetables would be removed as needed. In the cyclone cellar just out the kitchen door which was a large beehive like structure partly buried in the ground and made out of brick and mortar. It would be filled with apples and potatoes. A large grape arbor sheltered the walk from the kitchen to the sheds and outhouse. From the grape crop they made jellies, grape juice and wine. Their place was practically a self sustained and independent area. To day we rely upon the super market with all its fancy labels and packages. And the food additives


